Understanding:

1. Nazir Ajmal memorial College of Education, Hojai has become an academic partner of Rabindra Nath Tagore University, Hojai, Assam for creating a conducive situation for mutual exchange of expert opinion and use of infrastructure facilities under the following areas:
 - a) A close linkage and functional co-ordination between Nazir Ajmal memorial College of Education, Hojai and Rabindra Nath Tagore University, Hojai, Assam sharing of knowledge and best practices in classes through faculty and student exchange programmes.
 - b) Continual teacher education program to address the requirements of global teaching professionals.
 - c) Emerging Issues on Education.

2. Nazir Ajmal memorial College of Education, Hojai and Rabindra Nath Tagore University, Hojai, Assam shall work together to conduct short-term courses, diploma courses related to Education and general awareness about different areas and aspect of Education. 3. Any expenditure incurred through the joint programme will be born as per the terms of mutual agreement.

4. This agreement shall be the sole repository of terms agreed to between the parties and amendment shall take effect as and when required by concurrence of both parties. The agreement will be binding on both parties.
5. Nazir Ajmal memorial College of Education, Hojai and Rabindra Nath Tagore University, Hojai, Assam is recorded in writing and signed by both parties. Both parties shall be consulted before any such amendment is brought into effect.


This Memorandum of Understanding will be effective upon signature by both the Chief Executive Officers for a period of five years, at which time the same will be reviewed for possible renewal for further five-year period. Either party may, on three (03) months notice in writing, terminate the MoU in advance of its normal expiration or request the recognition of its conditions.

IN WITNESS WHEREOF, this Memorandum of Understanding is executed hereto on the date of signing of the Memorandum of Understanding by the two parties.




