[Memorandum of Understanding (MoU)]

This Agreement [Memorandum of Understanding (MoU)] is executed on this Day of 2024 at Hojai Sankardev Nagar

Between

And

Hojai Girls College- as the Second Part;

Understanding:

2. Nazir Ajmal memorial College of Education, Hojai and Hojai Girls College shall work together to conduct short-term courses, diploma courses related to Education and general awareness about different areas and aspect of Education. The collaboration is expected to enhance training, research and developmental activities conducted through assimilation of emerging knowledge related to Education.

3. Any expenditure incurred through the joint programme will be born as per the terms of mutual agreement.

4. This agreement shall be the sole repository of terms agreed between the parties and amendment shall take effect as and when required by concurrence of both parties. The agreement will be binding on both parties.

5. Nazir Ajmal Memorial College of Education, Hojai and Hojai Girls College is recorded in writing and signed by both parties. Both parties shall be consulted before any such amendment is brought into effect.

This Memorandum of Understanding will be effective upon signature by both the Chief Executive Officers for a period of five years, at which time the same will be reviewed for possible renewal for further five years period. Either party may, on three (03) months notice in writing, terminate the MoU in advance of its normal expiration or request the recognition of its conditions.

Arbitration:

In case of any dispute relating to any aspect of collaboration under this MoU, the Principal, Hojai Girls College and the Principal, Nazir Ajmal Memorial College of Education, Hojai will jointly resolve the dispute in a spirit of mutual respect and shared responsibility.
